JOINT STIPULATION REQUESTING STAY OF PROCEEDINGS AND EXTENSION OF TRO (DKT. # 20)

4. Furthermore, the Parties have agreed to extend the duration of the

Temporary Restraining Order issued by this Court on August 10, 2017 (Docket No. 20)

until this Friday August 25, 2017. The Parties expect to further extend the Temporary

Restraining Order pursuant to the terms of the Parties' settlement agreement.

WHEREFORE, Rural Route 3 Holdings, L.P. and Patrick A. P. de Man

respectfully request that the Honorable Court:

A. Stay the proceedings in this case (including without limitation the

TRO/Preliminary Injunction hearing scheduled for this Thursday August 24, 2017) for a

period not to exceed four (4) days, that is, until this Friday August 25, 2017; and

B. Extend the duration of the Temporary Restraining Order issued by this

Court on August 10, 2017 (Docket No. 20) until this Friday August 25, 2017; providing

that it may be further extended pursuant to the terms of the Parties' settlement agreement.
