## **DECLARATION OF CRAIG TAYLOR**

COUNTY OF NEW YORK §

- 1. "My name is Craig Taylor. I am above the age of eighteen years and understand the nature and obligation of an oath. I have personal knowledge of each of the facts and statements contained within this Declaration and each of them is true and correct.
- 2. I am President of Atlas Commodities, LLC ("Atlas"). Atlas is an energy brokerage.
- 3. On December 22, 2013 at 12:06 a.m., four months after execution of the Settlement Agreement, I received a text message from Adam Sinn. The message contained no text, just a photograph of Sinn, Eric Torres, Barry Hammond (one of Sinn's lawyers), and a few other energy traders, Evan Caron, Paul Sarver, and Sean Kelly. They were standing in front of a Christmas tree—and all but Caron were extending their middle fingers at the camera. A true and correct copy of that photograph is attached as Exhibit A to Defendants' Response to Plaintiff/Counter-Defendants Motion for Summary Judgment and Defendants' Response to Plaintiff/Counter-Defendants Adam Sinn, XS Capital Investments, L.P., and Aspire Commodities, L.P.'s Motion for Summary Judgment.
- 4. At the time the picture was taken, Caron was a trader at Mercuria Energy Group ("Mercuria"), and Kelly was a trader at E.ON Energy ("E.ON"). At that time, Atlas was doing business with both Mercuria and E.ON. Mercuria and E.ON were customers of Atlas.
- 5. Also at the time the picture was taken, Sarver worked for a competitor of Atlas, Bosworth.
- 6. Atlas was harmed by Sinn and Torres' disparagement. Shortly after the December 22, 2013



incident, Mercuria ceased doing business with Atlas.

- 7. On August 15, 2013, I executed a Settlement Agreement on my behalf and on behalf of Atlas, pursuant to which Atlas, James Marshall, and I agreed to pay Torres a sum of money in exchange for his return of shares in Atlas. Paragraph 27 of the agreement contained a non-assignment provision, which was material to my executing the agreement. I did not consent to Torres' assignment of his right to payment under that agreement to Sinn, nor would I have had I been asked. A true and correct copy of that Settlement Agreement is attached as Exhibit M to Defendants' Response to Plaintiff/Counter-Defendant Eric Torres' Motion for Summary Judgment and Defendants' Response to Plaintiff/Counter-Defendants Adam Sinn, XS Capital Investments, L.P., and Aspire Commodities, L.P.'s Motion for Summary Judgment.
- 8. My name is Craig Taylor, my date of birth is July 24, 1970, and my address is 24 East Greenway Plaza, Suite 445, Houston, TX 77046. I declare under penalty of perjury that the foregoing is true and correct."
